## Acceptance of the Terms of Use

These Terms of Use (hereinafter the "Terms") are for the legal framework of the use of the site enjoy-models.com. This contract is concluded between ENJOY MODELS and any natural or legal person wishing to access the Site and its services, hereinafter called the user. The Site and its various services may be interrupted or suspended by ENJOY MODELS, in particular during a maintenance, without obligation of notice or justification. The User, having access to this Site, agrees to comply with these Terms.

## Intellectual property

The entire site enjoy-models.com (hereinafter the "Site") comes under French law and as such is protected by the provisions of the Code of Intellectual Property, in particular by those of its provisions relating to property literary and artistic rights, copyright and the protection of databases. These rights are the exclusive property of ENJOY MODELS. Any unauthorized representation or reproduction of the Site, by any means whatsoever, is strictly prohibited under penalty of prosecution.

## Hypertext links

ENJOY MODELS may offer on the Site links to third party sites. These links are established in agreement with the sites concerned at a time when ENJOY MODELS may have deemed it appropriate to do so, given the content and services of these sites. # **Collection of data and information**

This policy details how the company ENJOY MODELS, having the status of controller in the meaning of the regulations applicable to the protection of personal data, processes the user's personal data (hereinafter the "Data").

By using this Site, the user agrees to consent to and accept the collection and use of his Data as described below.

# Security and confidentiality of data

ENJOY MODELS implements technical and organizational security measures in accordance with the rules of the art, in particular as regards the security of its information system. ENJOY MODELS endeavors to take all measures necessary to preserve the confidentiality and security of the User's Data and prevent it from being altered, damaged, destroyed or unauthorized third parties having access to it. In this respect, ENJOY MODELS ensures that its subcontractors, in particular the Service Provider, offer the same security, technical and organizational guarantees.

# Application

Any major user according to the law of the country of his nationality may submit an application on the Site by completing the online form. Underage users within the meaning of the law of the country of their nationality must, for their part, have previously obtained the agreement of their legal representative before completing the online form.

Each candidate therefore declares and certifies, either to be of legal age or, for minors, to have obtained the prior agreement of his legal representative. ENJOY MODELS reserves the right to contact or not to contact the Candidates based on the information provided by them using the form available online on the Site and the compatibility of this information with the recruitment criteria set by ENJOY MODELS account given the specifics of the manikin activity. ENJOY MODELS makes no commitment to Candidates and reminds that the commitment of a manikin for a mission can only be made by signing a contract between the manikin and ENJOY MODELS.

By applying on the Site, the candidate accepts these Terms and gives his consent to the collection and processing of his data for the purposes of the study of his application and its treatment.

The data collected and processed by ENJOY MODELS include names, first names, contact details, date and place of birth, nationality as well as physical data concerning the measurements (size, size, ...) or appearance (colors of the eyes, hair , distinctive signs) taking into account the specificities of the model activity. ENJOY MODELS will make only internal and private use of the photographs provided by the candidates for the needs of the management of the candidatures, to the exclusion of any other use. Candidates guarantee that they are entitled to use the photographs they send to ENJOY MODELS for the purposes specified in the paragraph above.

ENJOY MODELS keeps this personal data for 1 year from the date of receipt before proceeding to their complete destruction.

#### Cookies

The navigation on the Site gives rise to the deposit of cookies on the user's terminal. Cookies are small text files that can be saved in a dedicated area of the hard drive of the user's terminal (computer, tablet, smartphone) during the consultation of an online service with the browser software grouping a number of User Navigation Data (eg date, time and number of visits, arrival source, preferences). This information is never processed individually by ENJOY MODELS.

ENJOY MODELS uses cookies to analyze the activity of the Site: the deposit of cookies allows to obtain information on the affluence and the traffic of the Site and thus to measure its performances and to make available to the user buttons to access the Facebook and Instagram account of ENJOY MODELS. If the user clicks on one of them, other cookies may be deposited by these social networks on his terminal. These cookies are governed by the personal data

protection policy of each social network. ENJOY MODELS therefore has no control over their deposit.

The deposit of cookies on the user's terminal assumes the collection of his consent which has a validity period of 13 months maximum. This delay is not extended by the new visits of the user. Upon arrival on the Site, an information banner indicates that ENJOY MODELS uses this technology and that by continuing its navigation, the user accepts the deposit of cookies on his terminal. The data generated by cookies to analyze the activity of the Site (including the IP address of the user) will be transmitted and stored by Google on servers located in the United States. This transfer of data to the United States of America is framed by the Privacy Shield between the European Union and the USA. The user can manage the deposit of cookies using the setting of his browser. This setting may change his browsing on the Internet and the conditions of access to certain services that require the use of cookies.

If the user does not want the registration of these cookies, he can oppose by disabling cookies in his browser. To know how to proceed, the user must refer to the help section of his browser.

The removal of functional cookies, which are necessary for the provision of content by ENJOY MODELS, may prevent the user from accessing certain contents of the Site. ENJOY MODELS declines any responsibility for the consequences related to the degraded operation of its Site resulting from the impossibility of registering or consulting the cookies necessary to the functioning of the Site, and of which the user would have refused the deposit or required the suppression.

## **Data Recipients**

As part of the processing of User Data, ENJOY MODELS may transmit or provide access for purely technical and logistical reasons, to the following categories of Data Subcontractors:

# **Rights of the User**

These identity documents will be retained one (1) and one exercise of the rights of access and rectification and three (3) and the right of opposition.

## **Right to lodge a complaint**
